All requirements specified under Section 3 of Center Township Ordinance 87-3 (Amended) must be complied with.

The Logging Contractor shall notify the Center Township Zoning Officer no less than forty-eight (48) hours prior to commencing logging activities.

The Logging Contractor shall post a bond of \$500.00 per acre of area disturbed for logging road construction plus \$25.00 per acre of area logged to guarantee restoration of the property as per Section 5 of Center Township Ordinance 87-3 (Amended).

Any hauling of logging materials on Township roads must comply with Section 4 of Center Township Ordinance 87-3 (Amended).

The Hauling Contractor must notify the Center Township Engineer no less than forty-eight (48) hours in advance of any hauling activities as to what Township road will be hauled upon.

Prior to hauling on any Township road, the Logging Contractor shall post a bond to guarantee restoration of roads damaged by the hauling, as per Section 5 of Center Township Ordinance 87-3 (Amended).

GENERAL PROVISIONS AND REQUIREMENTS

This permit is valid for a period of one (1) year after date of issuance.

Logs may be sold commercially on site only if the property is located in a commercial zone.

Bonds shall be released by the Township at completion of project only after the Township Engineer and the Zoning Officer determine that the Ordinance requirements have been followed.

This application is contingent on the contractor and owner complying with all existing local, county, state and federal regulations. No deviation from the plan shall be made, except after written notice to and a favorable opinion is rendered by the Township Engineer.

Failure to comply with any section of this application is just cause for the Zoning Officer to stop work on the project.

Applicant/ owner hereby certifies that the statements made herein, and representations contained in all accompanying matter made part of this application, are true and correct. Also, the undersigned hereby agrees to the provisions, conditions and limitations set forth in Center Township Ordinance 87-3 (Amended) for any and all logging activities.
