The Township shall prepare resolution of approval signed by the Applicant and thus recorded through the Township.
  - c. A recording plat may be larger than 8 ½ "x 11", but no larger than 24"x 36" and shall be drawn at a scale of not less than 100' to 1". Any re-recording plat larger than 8 1/2" x 11" shall have the required certificates, affidavits, and endorsements.
  - d. Also submitted are 13 (thirteen) copies (prints) of the Final Site Plan Recording Plat.
