This permit is issued pursuant to the provisions, conditions, and limitations of the Center Township Code, as amended, and the representations made by owner (or authorized agent), in the Application for Driveway Permit No. _____, as filed with the Township of Center. This Driveway Permit authorizes only such work as that which the Township has by endorsement of said Application, approved.

This permit shall be summarily revoked upon discovery of any false statement or material misrepresentation made by owner (or authorized agent), in said Application.

This permit shall be revoked in the event that the work of the permitted construction is not commenced within 180 days from the issue date shown above. This permit shall expire one (1) year after the issue date shown above or upon completion of the permitted construction, whichever event shall first occur.

This permit does not authorize Final Acceptance of the permitted construction. Upon completion of the permitted construction, owner (or authorized agent) must secure from the Township for a Final Inspection Report before Final Acceptance of the permitted construction may be lawfully completed.

This permit must be posted in accordance with the provisions of the Center Township Code, as amended.
